

## **Power Living Yoga Australia**

### **Terms and Conditions: 200 hour Hybrid Teacher Training Program**

#### **1. Payment Policy**

- (a) A first payment installment deposit in the amount of \$1039 / \$1139 (depending on payment plan structure chosen by the student) is required to be paid at the time of enrolment to secure your place in the course. The deposit is non-refundable and non-transferable.
- (b) The remaining balance of the tuition fees will be debited on the same date of initial purchase for the following 2 months
- (c) In full Payment: This payment is taken in full on enrollment in the course, depending on the time of purchase in line with the payment plan options, a non-refundable and non-transferable deposit will be held to the amount of either \$1039 / \$1139
- (d) All participants are required to purchase two compulsory textbooks, full details of these books will be provided prior to the course start date.

#### **2. Refund and Cancellation Policy**

- (a) Refunds will only be given according to the following provisions:
  - (i) If you cancel 30 or more days prior to the course start date, your payment of the tuition fee will be refunded less the first payment installment
  - (ii) If you cancel less than 30 days prior to the course start date or after the course start date up to completion of the first week, you will be refunded 50% of the tuition fee (if paid in full) less the first payment installment deposit
  - (iii) If you cancel after the completion of the first week, you will not be eligible for any refund of the tuition fees and will be charged the full balance due.
- (b) Power Living is not responsible for the cancellation, suspension, rescheduling or reduction of any aspects of our teacher training program due to occurrences or circumstances beyond its control including without limitation natural disaster, acts of war, military activity, terrorism, epidemic, municipal, statutory or civil authority requisition, fire, flood, tempest, excessively inclement weather, earthquake, damage caused by an aerial object or aircraft, strikes or lockouts or other similar act of god events.
- (c) Power Living reserves the right to cancel any education program prior to the course commencement date at its sole discretion. In this event, Power Living will refund the course fees in full.
- (d) Power Living shall not be liable for any loss sustained by students directly or indirectly attributable to the cancellation, suspension, rescheduling or reduction of the scheduled program due to any of the occurrences or circumstances set out above subject to clause 2(c).

#### **3. Course Completion**

- (a) Participants are required to complete **every** session of the program
- (b) You are able to complete the course at your own pace, however we suggest you try and follow the provided schedule as recommended for optimal learning.

#### **4. Permission to Use Photographs and Footage**

- (a) I agree to allow Power Living and its associated entities to use photographs and video footage of me in publications and promotional materials for Power Living, all of

which are made public via print publications, their website and/or on social media platforms. I understand that the use of all photographs/ footage will be anonymous; my name will NOT be used. I understand that photographs/ footage may be used in publications for the next ten years.

- (b) Upon submitting my application for enrolment onto the above program I confirm that I have read, understood and agreed to the terms and conditions of undertaking this program at Power Living.

## **5. Physical and mental conditions**

- (a) I acknowledge and understand that as part of the program, I will be participating in a range of sessions, events and workshops. I acknowledge that participating in certain activities may open up new learning on a physical level as well as on a mental, emotional and spiritual level. This may be both deeply rewarding, transformational but also challenging. I acknowledge that my physical and mental health is my responsibility. I take full responsibility for my physical and emotional state throughout the program and will only participate to a level where I feel comfortable and safe.
- (b) I acknowledge and understand that the team at Power Living are not qualified medical professionals or registered counsellors or psychotherapists. The program and activities offered by Power Living are not medical or therapeutic in nature. Power Living may recommend certain service providers to assist students who wish to access other forms of assistance, however Power Living gives no guarantees and makes no representations or warranties as to the availability, quality or suitability of the service providers and the services provided.

### ***Notes on Terms***

For modules offered in more than one session, in which all sessions are required for module completion, program cost refers to the total cost of all sessions within that module. Refunds are based on full module length according to the terms of the cancellation policy above.

For programs with multiple modules, program cost is determined based on each separate module at a time. Program start date refers to the start of each module.
